

# 2022 Teton County Republican Party Resolutions

## The Teton County Republican Party:

## **Quality of Life**

3. Support zoning that enables private sector workforce housing solutions.
4. Supports continuing to use the Wyoming Regional Cost of Living Index to fund Teton County School District.
5. Encourages the Wyoming Legislature to fund K-12 education, including acquisition of lands for new schools and construction funding for schools and school safety as a priority.
6. Opposes critical race theory (CRT) or any of its derivatives in Wyoming education.
7. Supports legislation to eliminate biological males from competing in women's sports.
8. Supports local law enforcement and first responders.
9. Opposes all COVID-19 mask and vaccine mandates.
10. Supports a restriction of cross-over voting to 90 days before a primary election.
11. Since an educated and skilled labor force is essential to attract and retain business, we support the implementation of policies and procedures that encourage our young people and families to remain in or return to Wyoming.

12. Supports the enhancement of developed telecommunications, broadband, and wireless internet infrastructure in Teton County and the State of Wyoming.
13. Encourages the Wyoming Legislature in promoting a statewide infrastructure for the health, safety, and welfare of the Wyoming mentally ill.
14. Supports a more representative 5-member county commission selected by Districts rather than “at large.”
15. Maintain year round 45 mph speed limit from Snake River Bridge to Spring Creek Junction stoplight on Hwy. 22.
16. Supports retaining the 3-hour parking limit in downtown Jackson, opposes paid parking, removing hourly limits at the Home Ranch Lot, and no overnight parking at the Home Ranch Lot.
17. Supports maintaining year-round daylight savings time.

### **Economic Vibrancy**

18. Supports local government that practices fiscal conservatism, responsible taxation, and accountability and private property rights and individual freedoms.
19. Supports job creation and diversification utilizing existing infrastructure that promotes business development while opposing city and town policies that restrict and inhibit small business opportunities.
20. Encourages reduction in regulations, establish fair and simple fee structure, and cooperation from County and Town so that residential and non-residential development is an active part of the economy.
21. Supports the continued state funding for local governments while encouraging reduction in size and cost of local governing entities.
22. Supports formation of a small business and self-employed health insurance pool to purchase health insurance in Wyoming and support Congressional action to allow interstate or multistate purchase of health insurance.
23. Supports a diversified Wyoming economy to weather the peaks and valleys of the present Wyoming dependence on non-renewable energy.

### **Fiscal Responsibility & Transparency**

24. Supports efforts to reduce federal spending, balance our federal budget, reduce the national debt, and efforts to curb local spending.

25. Opposes any increase in County or Town sales tax.

### **Respect, Protect, and Promote Knowledge of our U.S. Constitutional Rights**

26. Demands strict adherence to the U.S. Constitution.

27. Encourages the education system of Teton County School District to find ways of teaching every student throughout the K-12 grades about the U.S. Constitution.

28. Supports free, open, and civil debate on any and all issues.

29. Wyoming has a good reputation in fair elections, but we do not want to take a chance on fraud. To prevent electronic vote manipulation, we propose:

- a) All voter machines shall not be connected to the internet.
- b) Picture voter I.D. is to be required.
- c) Universal signature matching.
- d) Verify citizenship.
- e) No mail in voting except absentee, when necessary.
- f) No ballot harvesting.
- g) Eliminate drop boxes.
- h) Each voter should be able to track their own vote.

30. Opposes Section 230 of Title 217 of the United States Code which allows a double standard for tech companies.

31. Supports the enforcement of our immigration laws.

32. Supports the use of English as the official language of the United States.

### **Respect for Teton County Heritage**

33. Opposes any further development/encroachment of the Rodeo and Fairgrounds land.

### **Conservation & Responsible Stewardship of our Land and Natural Resources**

34. Supports the conservation and protection of natural resources, wildlife, and open spaces on public land without any intrusion of private property rights.

35. Recognizes National Parks & National Forests are important economic factors in Teton County and Wyoming.

36. Recognizes efforts to use all energy forms in our community and nation, where appropriate, and maximize the use of Wyoming's energy resources.

37. Supports hunting and fishing as an important economic factor in Teton County and Wyoming and supports continued hunting and fishing on public and private lands.
38. Supports multiple use of BLM and non-wilderness areas of our National Forests.
39. Advocates for state management of all species, especially large carnivores.
40. Supports the continued feeding of elk on the National Elk Refuge, when needed.
